### 1. General Manager's Report

#### Discussion:

- Paratransit buses undergoing warranty work are now receiving some priority at the dealership, though supply chain challenges and labour shortages are having an impact.
- Information was received just this morning related to some funding applications but has not yet been reviewed. The General Manager will circulate any updates after the meeting.
- There have been some applications submitted for the vacant Commissioner position. The deadline for submissions is tomorrow. Once all applications are received, the selection committee will meet to review and bring forward a recommendation to the Commission.

## 2. Executive Summary Report

#### Discussion:

- Regarding GoBus no-shows, it was noted that Tok Transit does not have an
  option in place for customers to leave an after-hours telephone message to
  cancel an early morning trip. This is likely contributing to the number of noshows. A request will be made to Tok to address this.
- An error was noted in the Finance section of the report, identifying a 4% increase in ridership compared to 2019. This value should be 25%.
