Paradise has requested to increase their service frequency during the day, which is manageable within Metrobus' existing resources. At present, it is not known what improvements Mount Pearl is planning. Staff will reach out to determine if Metrobus can accommodate their requests.

ii. Executive Summary Report

This week, staff have started doing sessions with the Association of New Canadians, with the help of interpreters, to support immigrants in learning how to use the bus. These sessions will benefit the community overall and help sustain ridership.
